Stronger ministry oversight of multi-year contract needed

VICTORIA – The Office of the Auditor General of British Columbia has released a new report: *An Audit of the Contract for the Family Maintenance Enforcement Program.*

The Family Maintenance Enforcement Program collects and issues payments for child and spousal support.

"Last year, this program helped families receive over \$200 million in support payments that they're entitled to," said Auditor General Carol Bellringer. "Our audit focused on the Ministry of Justice's management of the contract for this program, and not the quality of service being provided."

A private sector contractor delivers the program on behalf of the ministry. The same service provider has held the contract since the ministry outsourced program delivery in 1988. Over the last 10 years, the ministry has paid about \$160 million to the service provider to deliver the program.

The audit found that in 2006, when the contract was most recently up for tender, the ministry did not follow good procurement practices. Specifically, the ministry didn't choose the right procurement strategy given the limited number of potential service providers. Its strategy also didn't generate competition; nor did the ministry respond appropriately to the lack of competition.

"Our findings reinforce that ministries need to choose the right procurement strategies to achieve competition and demonstrate value for money when using contractors to provide government services," said Bellringer. "It's not enough to just follow policy requirements; for the most part, the ministry did that and still didn't achieve competition, which is a key principle of fair and open public sector procurement."

The audit also identified challenges managing the contract over the years. These challenges should have triggered greater oversight by the ministry. For example, 10 years of negotiating with the service provider has not produced a new contract, increasing program costs have resulted in the program regularly requesting and receiving additional funding, and there are numerous outstanding recommendations for improvement from multiple external assessments of the program.
